



Camp Cedar Ridge Guest Policies

Check in time: 4:00 PM Check out time: 11:00 AM (except by special arrangement)

General Policies

1. Respect the health and safety of others and yourself
2. Harassment in any form based on, but not limited to, religion, spirituality, sexual preferences, race, gender or age is not allowed.
3. Don't approach, harass, injure, or feed, any of the wildlife that roams around the property.
4. Parking is only permitted in the parking lot at the entrance. For special events, other parking may be designated. Cars may be parked by the house, lodge and bunkhouses, for loading and unloading only. Buses should follow signs. There is no parking by the camp store or the dining room.
5. There is no amplified music after 10:00 PM. Groups sharing the facility should keep noise down after 10:00 PM. Quiet hours are 10:00 PM-7:00 AM.
6. Smoking is allowed in designated areas only.
7. Shirts and shoes required in the Dining Room.
8. No nails or screws can be used to secure items.
9. The use of water balloons is prohibited.
10. No firearms permitted.
11. No illegal drugs are allowed on the property or persons under influence of drugs.
12. Children under the age of 13 must be supervised by an adult at all times. Group leaders and/or parents or guardians are responsible for the behavior and adequate supervision of youth 13-17.
13. There will be a pre- and post-walk-through conducted. It is the guest's responsibility to conduct a walk-through and report any damage to the Camp Cedar Ridge Staff. All new damages will be your responsibility.
14. The facilities are to be kept clean and organized at all times during the duration of the contract. The facilities are to be left clean and in the same condition as they were at check-in. Guests should turn off lights and heaters and leave doors closed at check-out.
15. All furniture, housewares, bedding and goods located inside the property buildings are to remain in their proper locations. At no time are furniture, housewares, towels or other indoor goods to be moved outside.
16. Any and all precautions must be made in all buildings to ensure there is no smoke or fire damage to any part of the property, including, but not limited to: carpets, walls, ceilings, tile, tables and chairs. Incense and candles must be supervised at all times.
17. The creek and its banks are not on Camp Cedar Ridge property. Guests access it at their own risk.

18. There are hiking trails on Camp Cedar Ridge. Please hike in groups of at least 2 or tell someone in your group or the Camp Cedar Ridge staff, where you are going and when you plan to return. Hiking apparel is recommended.
19. Fires are allowed in firepits, at times during the year when fires are permitted. They must be pre-arranged with the Camp Cedar Ridge staff and use Camp Cedar Ridge firewood or approved outside firewood. Guests are not to cut limbs or trees or burn branches from the ground or help themselves to stack firewood without assistance.
20. Guest should never enter the pool area unless the gate is unlocked. If there are any members of the group who are under 18, a lifeguard must be on duty. Guests must observe all the pool rules and instructions of the lifeguard.
21. Use of the slip and slide is only allowed while supervised by CCR staff.
22. Camp Cedar Ridge reserves the right to refuse access to the pool and slip and slide.
23. Staff housing areas are private and should not be entered by guests without an invitation.

Dogs

For the safety of dogs and others, please read and familiarize yourself with our dog rules. All dogs must be on a leash.

- Dogs may not be tied out or tied to trees.
- Owners should always maintain physical control of their animal.
- When away from your dog, it must be in a kennel.
- Dogs are not to be confined to your vehicle in extreme heat or cold.
- Dogs are not allowed in the dining hall or shower house.
- Do not bring your dog to camp if it has known aggression issues. If your dog is aggressive, you will be asked to remove your dog from the property.
- If your dog becomes a nuisance, as in the case of excessive dog barking, you will be asked to remove your dog from the property.
- Owners must pick up after their dogs.
